The Claris FileMaker Server ("FileMaker Server") software identified herein and documentation accompanying this License ("Software") are licensed, not sold, to you by Claris International Inc. and/or Claris International (collectively referred to as "Claris") for use only under the terms of this License, and Claris reserves any rights not expressly granted to you. The rights granted are limited to Claris's and its licensors' intellectual property rights in the Software, only as detailed herein, and do not include any other patents, intellectual property or other rights. You own the media on which the Software is recorded or fixed, but Claris and its licensors retain ownership of the Software itself.

If you received a trial version of the Software for your limited evaluation, it is programmed to cease functioning on a certain date as communicated to you, Section 1(c) below is modified to allow you to use an unlimited quantity of user licenses during the trial period, and Section 5 below is modified so that the trial version of the Software is provided "AS IS" and "WITHOUT WARRANTY OF ANY KIND." All other terms below apply to both the trial and full versions of the Software. Upon expiration of the trial Software, unless you have paid for the full or upgrade version of the Software, you must immediately discontinue use of the trial Software.

1. License.

(a) **General License.** The Software consists only of the following components: database server, web publishing engine, web server module, script engine, FileMaker Admin API, FileMaker Data API and ODBC/JDBC connectivity APIs. You may either (1) install all the Software components on a single computer, or (2) install the web publishing engine component on one computer and all the other components on one other computer. You may not use or run more than one instance of the Software from the same operating system (e.g., using virtualization or other technologies) at the same time.

(b) **Client Drivers.** The FileMaker ODBC/JDBC "Client Drivers" are the driver portions of the Software that allow third party applications or custom applications to access FileMaker Server as an ODBC or JDBC data source. You may copy and distribute the Client Drivers for use on more than one computer, provided that the Client Drivers may only be used with the Software.

(c) **User Access.** The Software includes the rights to access data stored in the database server using the FileMaker WebDirect web browser client, the Claris FileMaker Go client and the Claris FileMaker

Pro (“FileMaker Pro”) client (collectively “Client(s”). You are required to purchase appropriate access to the Software depending on the license type under which you purchase:

(i.) User License. If you are purchasing access to the Software under a user license (“User License”) the following terms apply (and the terms in section 1(c)(ii) below do not apply to you). Your company or organization who has licensed the Software under a User License contract must purchase a license for each unique individual who will access the Software using a Client. This unique individual who has a license to access the Software is defined as a “User.” A User can use any Client to access the Software. A User can use any Client to access FileMaker Server purchased under a Concurrent Connections License contract as long as they have a valid User License and use that User License when accessing the FileMaker Server. You may not allow any FileMaker Pro clients purchased under a Concurrent Connections License contract to access this Software.

(ii.) Concurrent Connections License. If you are purchasing access to the Software under a Concurrent Connections License then the following terms apply (and the terms in section 1(c)(i) above do not apply to you). Your Organization or Company who has licensed the software under a Concurrent Connections License contract (“Licensed Organization”) must purchase the number of concurrent connections licenses that represents the maximum number of individual connections that will concurrently access FileMaker Server at any given time. Each Client accessing FileMaker Server counts as a concurrent connection. You may only allow employees of your Licensed Organization to use the FileMaker Pro client to access this Software. You may also allow temporary employees, consultants or contractors of your Licensed Organization to use the FileMaker Pro client to access this Software only when they are conducting business on behalf of the Licensed Organization. If Licensed Organization is an educational institution, you may only allow enrolled students, faculty members, teaching assistants, administrators or staff to use the FileMaker Pro client on computers owned by your educational institution to access the Software. In the case of FileMaker WebDirect each web browser tab open and connected to FileMaker Server counts as a separate Client and will count as a concurrent connection. You may allow FileMaker Pro clients purchased under a User License contract to access the Software. If a single Client under a Concurrent Connections License contract accesses multiple FileMaker Servers at the same time, a concurrent connection is required for each FileMaker Server accessed by that individual Client. You may only use up to the total number of concurrent connections you have licensed at any given time.

Each individual license of FileMaker Pro (“Single License”) purchased allows access to FileMaker Server for the computer on which a Single License is installed and such access does not count against any other license type you may have purchased.

(d) **FileMaker Data API/OData License.** The Claris FileMaker Data API and OData features (“Data API/OData Features”) allow you to pull and push data from and to the database on your FileMaker Server by making REST API data requests (each a “Data Request”) to the database on your FileMaker Server. The number of Data Requests you may make is limited by the amount of API data transfer (“API Data Transfer”) you receive with your contract. For inbound Data Requests (pulling data into the database on your FileMaker Server) you have unlimited API Data Transfer. For outbound Data Requests (pushing data out from the database on your FileMaker Server) you are limited to the API Data Transfer included with the Software along with any additional API Data Transfer that you purchase. If you purchased the Software under a User License contract or a Site License contract, which is subject to additional terms,

then the API Data Transfer you receive under your User License contract or Site License contract is shared among all the FileMaker Servers you receive under each User License or Site License contract. You cannot use the Data API as a client replacement. By way of example, if you intend to serve 10 users, you must purchase a 10 user license or concurrent connections license. The API Data Transfer you receive is for an annual term based on the start date of your contract, and any unused API Data Transfer will not roll over to the next annual term.

(e) **Annual Licenses and Limited Term Licenses.** If you license the Software under an annual license or other limited term license (e.g., Annual Volume License Agreement or Annual Site License Agreement), then you may only use the Software during the term of the license agreement, and you must cease all use of the Software upon the expiration of your license agreement.

(f) **Backup.** You may make one copy of the Software in machine readable form solely for backup purposes. As an express condition of this License, you must reproduce on each copy any copyright notice or other proprietary notice that is on the original copy supplied by Claris.

(g) **Upgrades & Updates.** If the Software is licensed as a version or feature upgrade or update, then you may only use the Software to replace a validly licensed version of the same software. You agree that the upgrade or update does not constitute the granting of a second license to the Software (i.e., you may not use the upgrade or update in addition to the software it is replacing, nor may you transfer the software which is being replaced to a third party). The terms of this License will govern any software upgrades or updates provided by Claris to the Software, unless such upgrade or update is accompanied by a separate license in which case you agree that the terms of that license will govern such upgrade or update.

(h) **Education.** If the Software is licensed at an education discount, then the Software may only be used by enrolled students, faculty, teachers, staff and administrators at an accredited K-12 educational institution (or equivalent) or higher education institution exclusively for educational purposes.

2. **Restrictions.**

(a) **FileMaker Server Testing License.** If you have licensed FileMaker Server under the FileMaker Developer Subscription, then your use of this Software is limited to the Maximum Number of User Licenses, ODBC/JDBC, FileMaker Data API data transfer amount, and Web Sessions as specified under the FileMaker Developer Subscription. In addition, the Software provided under the FileMaker Developer Subscription may only be used for development and testing purposes and it may not be used in a production environment.

(b) **Other Limitations.** YOU MAY NOT REVERSE ENGINEER, DECOMPILE OR DISASSEMBLE THE SOFTWARE, EXCEPT AND ONLY TO THE EXTENT EXPRESSLY PERMITTED BY APPLICABLE LAW. YOU MAY NOT MODIFY, ADAPT, TRANSLATE, RENT, LEASE, LOAN OR CREATE DERIVATIVE WORKS BASED UPON THE SOFTWARE OR ANY PART THEREOF.

(c) **Restricted Uses.** THE SOFTWARE IS NOT INTENDED FOR USE IN THE OPERATION OF NUCLEAR FACILITIES, AIRCRAFT NAVIGATION OR COMMUNICATION SYSTEMS, AIR TRAFFIC CONTROL SYSTEMS, LIFE SUPPORT MACHINES OR OTHER EQUIPMENT IN WHICH THE FAILURE OF THE SOFTWARE COULD LEAD TO DEATH, PERSONAL INJURY, OR SEVERE PHYSICAL OR ENVIRONMENTAL DAMAGE.

(d) **Transfer Restriction.** YOU MAY NOT TRANSFER OR ASSIGN YOUR RIGHTS UNDER THIS LICENSE TO ANOTHER PARTY WITHOUT THE PRIOR WRITTEN CONSENT OF CLARIS.

(e) **Third Party Acknowledgements.** Certain components of the Software, and third party open source programs included with the Software, have been or may be made available by Claris on its web site (<https://www.claris.com/resources/downloads/>). Acknowledgements, licensing terms and disclaimers for such material are contained online at <https://www.claris.com/company/legal/third-party-acknowledgements.html>, or may otherwise accompany such material, and your use of such material is governed by their respective terms.

(f) **Commercial Hosting Restrictions.** If you provide commercial hosting, you may only allow one customer to access each Software license. You must obtain at least one FileMaker Server Software license for each customer that you provide hosting services. You may not use the Software to provide any commercial hosting if you license the Software under Claris's Site License Agreement or Annual Site License Agreement.

3. Termination. This License is effective until terminated. This License will terminate automatically without notice from Claris or judicial resolution if you fail to comply with any provision of this License. If you license the Software under an annual license or limited term license, then your licenses will immediately terminate and you must cease all use of the Software upon the expiration or termination of your license, unless you have paid to renew the license prior to its expiration or termination. Upon such expiration or termination you must destroy the Software, all accompanying written materials and all copies thereof, and Sections 5, 6, 7 and 8 will survive any termination or cancellation of this License.

4. Export Law Assurances. You may not use or otherwise export or re-export the Software except as authorized by United States law and the laws of the jurisdiction in which the Software was obtained. In particular, but without limitation, the Software may not be exported or re-exported (a) into any U.S. embargoed countries or (b) to anyone on the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of Commerce's Denied Person's List or Entity List. By using the Software, you represent and warrant that you are not located in, under control of, or a national or resident of any such country or on any such list. Claris's entire liability and your sole and exclusive remedy for any breach of the foregoing limited warranty will be, at Claris's option, replacement of the Software, refund of the purchase price, or repair of the Software.

(b) **Limitation.** CLARIS'S TOTAL LIABILITY TO YOU FOR DAMAGES FOR ANY CAUSE WHATSOEVER NOT EXCLUDED BY SECTION 6(a) ABOVE HOWSOEVER CAUSED (WHETHER IN CONTRACT, NEGLIGENCE OR OTHER TORT, UNDER STATUTE OR OTHERWISE HOWSOEVER ARISING) WILL BE LIMITED TO THE GREATER OF U.S.\$5.00 OR THE MONEY PAID FOR THE SOFTWARE THAT CAUSED THE DAMAGES. THE PARTIES AGREE THAT THIS LIMITATION OF REMEDIES AND DAMAGES PROVISION SHALL BE ENFORCED INDEPENDENTLY OF AND SURVIVE THE FAILURE OF ESSENTIAL PURPOSE OF ANY WARRANTY REMEDY.
